Regarding you letter and your request I am happy to explain the situation as follows: English Club TV channel is being broadcast from 3 different satellites and has 4 different version not taking into account a few more programs called English Club TV created for separate markets in associations with our partners and clients, licensees and franchisees, as well as a few streams that are going for and from OTT partners that may have different features, own programming, different adaptation and/programming blocks. So we are developing a big numbers of streams and having flexibility as one of the tasks of our distribution strategy we are trying to provide the materials and content that may as much as close to apply to the market we are operating on. That as you may understand is not very easy. What is out of discussions and for sure we drastically support the idea that legislation and orderliness are key principles of our existence and development. We always respect the Law we operate and demand this from our partners.

Regarding the monitoring and recording made on November 09, 2018 mentioned in your request dated January 25, 2019 I may assume that monitoring department fixed incorrect feed of English Club TV channel or used incorrect receiving specification of the feed.
