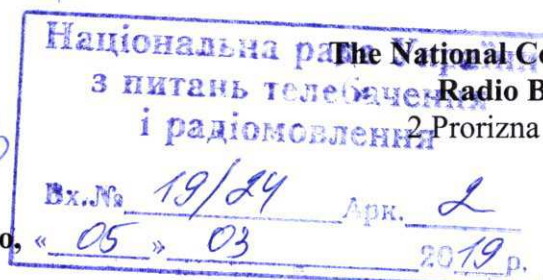

Dear Mr. Iurii Artemenko,

The National Electronic Mass Media Council of Latvia (hereafter referred to as the Council), following your request of 07 February 2019 informs you about broadcasting licenses No. AA-124/1 and No. AA-057/1 issued by the Council.

The license No. AA-124/1 issued on 17 November 2017 to *Ltd Teledistribution (ООО "ТЕЛЕДИСТРИБЬЮЦИЯ"; Teledistribucija LTD)*, registered in the Russian Federation with No.5047177891, for broadcasting the regional TV programme *LoLo Baltic* within the territory of the Republic of Latvia. (Please see the license here: https://neplpadome.lv/lv/assets/documents/Licences/TV/AA_124_1_1.pdf.) An integral part of the license are framework conditions with additional information about the TV programme, that includes information about the owner, broadcasting area, language, European works, etc. Regarding the license No. AA-124/1 for broadcasting TV programme *LoLo Baltic* in the framework conditions is stated that the broadcasting area for this TV programme is the Republic of Latvia via cable and internet, the licence does not cover broadcasting in any other territory except the Republic of Latvia. This broadcasting license does not provide the rights for transfrontier broadcasting, nor the broadcasting via satellite. Regarding two registered addresses indicated in the broadcasting license – first address (Latvija: Lizuma iela, Rīga, LV-1006) is a contact address in Latvia and the second address (Krievijas Federācija: Maksima Gorkovo iela 6A, ofiss 121, Pleskava, 180007) is a legal (registered) address of *Ltd Teledistribution (ООО "ТЕЛЕДИСТРИБЬЮЦИЯ"; Teledistribucija LTD)* in the Russian Federation.

Ltd Teledistribution Latvijas filiāle is a subsidiary to the Russian company *Ltd Teledistribution (ООО "ТЕЛЕДИСТРИБЬЮЦИЯ"; Teledistribucija LTD)*. *Ltd Teledistribution Latvijas filiāle* is registered in The Register of Enterprises of the Republic of

Latvia with No.40103958849. Owners of the Ltd Teledistribution Latvijas filiāle are Jeļena Grišina (20%) and Aleksandrs Aleksejevs (80%).

Ltd Teledistribution (ООО “ТЕЛЕДИСТРИБЬЮЦИЯ”; Teledistribucija LTD) possesses a licence (issued in the Russian Federation) for TV broadcasting of the programme *Про100ТВ (Pro100TV)*. The programme *Про100ТВ (Pro100TV)* is only retransmitted in the territory of Latvia via cable networks.

Concerning your request to inform about legal grounds that allow the *Ltd Teledistribution Latvijas filiāle* to broadcast (retransmit) the programmes *LoLo Baltic* and *Pro100tv Baltic*, and the status of the licence. We provide the following information.

The holder of the license No. AA-057/1 (programme *Pro100tv Baltic*) is electronic mass media *SIA “TVBC”*. The programme developer is *Ltd Teledistribution Latvijas filiāle* as mentioned in the section No.17 of broadcasting license No. AA-057/1 framework conditions. 
The holder of the license No. AA-124/1 (programme *LoLo Baltic*) is electronic mass media *Ltd Teledistribution (ООО “ТЕЛЕДИСТРИБЬЮЦИЯ”; Teledistribucija LTD)*. The programme developer is *Ltd Teledistribution Latvijas filiāle* as mentioned in the section No.17 of broadcasting license No. AA-124/1 framework conditions. (Please see the licence here: https://neplpadome.lv/lv/assets/documents/Licences/TV/AA_124_1_1.pdf.)

The Council informs that the both licenses (No. AA-057/1 issued to *SIA “TVBC”* and No. AA-124/1 issued to *Ltd Teledistribution (ООО “ТЕЛЕДИСТРИБЬЮЦИЯ”; Teledistribucija LTD)*) provides the content distribution rights in the territory of Latvia via cable networks and internet. According to the law this type of broadcasting license does not provide the rights for transfrontier broadcasting, nor the broadcasting via satellite.
